Overview This document is provided by the Welsh Government as a specification to support the above audience in developing their school information management systems to ensure that schools in Wales are able to submit data required to comply with statutory duties.

Action required For schools in Wales to be able to comply with statutory duties in supplying the required data returns, the Welsh Government recommends that software suppliers of school information management systems that have customers in Wales take full consideration of this specification document when developing their systems.

1. Introduction

This Post-16 collection will gather data at a pupil, programme and activity level for the whole academic year **2025/2026**. It will be collected retrospectively in September and October **2026**.

This collection has two main purposes:

- to support the development of consistent performance measures for Post-16 learning, as recommended in the [Review of Qualifications for 14 to 19 year-olds](#). The Welsh Government will be working with local authorities, schools and colleges to develop the measures. It is intended that this will include pupil retention; so, in order to carry out the necessary analysis, data is required at pupil, programme and activity level; and
- following the introduction of Post-16 programmes of study, the collection of information began in 2015 in order to monitor delivery against plans and to ensure programme plans were being met.

1.1 Key features of the data collection

The data collection collects data relating to pupils taught in National Curriculum Years (NCY) 12, 13 and 14, in secondary and middle schools with designated sixth forms in Wales, who have an enrolment status of:

- C** Current (single registration at this school)
- M** Current main (dual registration)

It collects data for pupils up to and including 19 years of age on the 31 August 2025. Any pupils 20 years of age or over on this date are not to be included in the return.

Middle schools with a sixth form are required to complete this exercise under the same conditions as secondary schools.

Data is required at a programme of study and learning activity (i.e., course) level and not only at the pupil level.

Pupils should only have one open programme at any point during the reporting period but may have more than one closed programme(s).

Do not include data for pupils in NCY 11 or below, regardless of date of birth.

1.2 Changes in data requirements introduced in 2014

For Post-16 collections since 2014, the data required by the October deadline is for the previous academic year rather than a picture of Post-16 activity on a single day in September (i.e., a census). To measure pupil retention, the Welsh Government needs to collect data which enables us to calculate the proportion of pupils who started and completed their course and the proportion of all activities undertaken which were completed or aborted during the academic year. The few courses extending over two academic years will also be recognised.

1.3 Look up tables

The following look up tables will be valid for the 2026 Post-16 collection:

- P16LearningProvidersList; and
- P16LearningProgrammesList.

These look up tables can be found under the **P16 tab** within **Modular CBDS 2627.1.n** and have been updated for the coming collection.

As of 7 March 2019, the Welsh Government no longer provides a Qualifications Wales Approval Designation (QWAD) list via DEWi. The QWAD details can be viewed by suppliers on the [Qualifications in Wales \(QiW\) website](#). The Welsh Government will no longer provide a QWADList.xsd, QWADList.xml or QWADList.csv look up table for suppliers. Suppliers will be able to extract the look up table themselves from the [QiW website](#). This will allow suppliers to have more control over when the database within their systems is to be updated, as per customer requirements, without having to rely on the Welsh Government to provide any updates to the look up tables.

Suppliers should contact Qualifications Wales directly at enquiries@qualificationswales.org for queries relating to the content of the qualifications or their respective awarding body.

The QWAD number should be submitted without the '/'.

Please note it is the QWAD number which must be used to populate <QWAD> as this is used for Wales-only qualifications and these qualifications are not allocated an English qualification number (QAN). The Ofqual Qualification Number should **never** be used to populate the QWAD.

Suppliers should endeavour to make it as easy as possible for late changes to the learning provider and learning programme look up tables to be added into their systems.

1.4 Validations

Validation will be facilitated through provision of XSLT files for Post-16 2026.

As the XSLT for this collection will be part of the September release (2627.1.n), a final baselined set is due for release in spring to early summer 2026.

1.5 Summary reporting

A further set of XSLT files will be provided to process the XML data and produce a school summary report.

3. Post-16 data collection key date

Data on Post-16 pupil learning activities is required for the previous academic year (2024/25).

DEWi opens for Post-16 data submission on **15 September 2026**.

Deadline for data submission is **09 October 2025**.

3.1 October 2026

Data is required for pupils with an enrolment status of **C** (current) or **M** (main) who are on roll at any time in the previous academic year, i.e., between **1 September 2025** and **31 August 2026**.

Data is required for programmes of study and learning activities that are being undertaken any time in the previous academic year i.e., between **1 September 2025** and **31 August 2026**.

3.2 Clarification of Post-16 data requirements

Data requirements for Post-16 pupils for academic year 2025/26 follow the same pattern as 2024/25 for pupils in secondary and middle schools. Details are provided here for clarity and reference.

Secondary or Middle Schools with designated NCY 12 and 13 classes

Note: Although it is expected that for most pupils and activities, completion dates and status will not be defaults, these are left at values indicating 'continuing'.

Pupils can only be enrolled on one programme of study at any time. A new programme can be recorded only when the previous programme has a completion status of 2, 3, 4 or 5.

Changes to programmes during the academic year

Changes to programmes will normally take place at the start of the academic year, where a pupil changes their mind on which subjects they decide to take, or a complete switch into a vocational route.

Below are the actions to be undertaken for in-year transfers for 1-year programmes and 2-year programmes.

Guidance on programmes and funding is available from Post-16 Funding and Planning team via post16planningandfunding@gov.wales.

4. User requirements

Several default values, auto and block fill requirements are requested in order to minimise bureaucratic and administrative burdens in the process of producing an accurate Post-16 return.

4.1 Mandatory/optional items

Items marked as **M** (mandatory) in the [XML structure](#) are required data items. Schema checks will fail if these items are not present; valid data is required for each mandatory field.

Items marked as **O** (optional) in the XML example file may be missing. If no data is present 'no data, no tag' rule applies.

Where modules are optional, data items within may be marked as mandatory as they are required **if** the module is present.

4.2 Default values

- `<ReferenceDate>` must default to 2026-07-31
- `<Pupil><EnrolStatus>` should be defaulted to C
- `<Pupil><LearningActivity><LearningActivityStartDate>` should be defaulted to 2026-09-01
- `<Pupil><LearningActivity><LearningActivityExpectedEndDate>` should be defaulted to 2026-08-31
- `<Pupil><LearningActivity><LearningActivityEndDate>` should be defaulted to 9999-12-31
- `<Pupil><LearningActivity><LLDDLearner>` should be defaulted to 0
- `<Pupil><LearningActivity><LearningActivityProvider>` should be defaulted to S0000000
- `<Pupil><LearningActivity><CompletionStatus>` should be defaulted to 1
- `<Pupil><Programmes><ProgrammeStartDate>` should be defaulted to 2025-09-01
- `<Pupil><Programmes><ProgrammeExpectedEndDate>` should be defaulted to 2026-08-31
- `<Pupil><Programmes><ProgrammeActualEndDate>` should be defaulted to 9999-12-31
- `<Pupil><Programmes><ProgrammeCompletionStatus>` should be defaulted to 1
- `<Pupil><Programmes><LengthOfProgramme>` should be defaulted to 1
- `<Pupil><Programmes><YearOfProgramme>` should be defaulted to 1

No defaults other than those above should be applied.

4.3 Autofill values

Fields that are dependent on the value of other fields should be auto filled when

there is no doubt as to their value. Details are given in the XML Message Structure but comprise of:

- **<LearningActivityEndDate>** must be 9999-12-31 if **<CompletionStatus>** = 1
- **<ProgrammeActualEndDate>** must be 9999-12-31 if **<ProgrammeCompletionStatus>** = 1

4.4 Block entry

A block entry facility for fields could be used by schools at the beginning of the academic year to reduce burdens. This should allow schools to choose a selection of pupils (e.g., a year group, registration group or class) and specify a value to be applied to all. It should also allow data to be edited on an individual basis. The following fields should have this facility:

- **<QWAD>**
- **<LearningActivityProvider>**
- **<CompletionStatus>**
- **<WelshMediumLearningActivity>**
- **<ProgrammeReference>**
- **<ProgrammeCompletionStatus>**
- **<LengthOfProgramme>**
- **<YearOfProgramme>**

4.5 Pupil level checking reports

Users have expressed a need for a facility to enable them to print pupil summary sheets for data checking purposes. Such sheets would detail pupils by name and list the learning activities being returned for the pupil as part of the Post-16 return. This does not form part of the required functionality but is brought to the attention of suppliers in order that they may consider provision of this functionality to assist their users. Where adopted, response to this has been positive, and the feature should be retained.

4.6 Welsh Baccalaureate schools

Users have expressed a need for a facility to enable them to allow key skills to be entered easily for all pupils involved in Welsh Baccalaureate. Again, this does not form part of the required functionality but is brought to the attention of suppliers in order that they may consider provision of this functionality to assist their users.

4.7 Learning activity definition

Learning activities should only be recorded for learning that is intended to lead to an externally validated qualification (has a QWAD number assigned).

A learning activity is defined as 'the course that a pupil engages in with the aim of achieving a particular qualification'.

4.8 Individual learning modules

For instance, if a pupil is enrolled in three classes, one designed to teach BTEC National Diploma Business, another to teach AS level Mathematics and the third to teach GCSE Geology then that pupil will have three learning activities: BTEC National Diploma Business, AS Mathematics and GCSE Geology respectively. Individual elements of these learning activities, for example pure mathematics and core mathematics modules within an AS Mathematics learning activity that lead to one externally validated qualification should therefore be presented as one consolidated record.

School MIS software should ensure that individual modules of a learning activity, leading to duplicates of the same learning activity (QWAD number) are not included in Post-16 returns, except for certain QWAD numbers, such as Art & Design, which are detailed within [Validation CBDS 2627.1.n](#).

4.9 Repeating/resitting/retaking

If the pupil attends school for any classes, tutorials, or learning, regardless of the duration of the learning (e.g., full year, term, month or even a day) then a learning activity record should be submitted as part of a programme.

If for any reason the pupil sits the same exam again **only** and does not undertake any additional learning other than the repeated exam, then that exam should **not** be recorded as a learning activity as part of a programme.

5. File naming convention

5.1 XML data extraction

Long file names will be used.

The file extension will be XML.

The file name shall be constructed from the following components:

- (a) Origin Identifier (7 digits)¹
- (b) Survey/Data Extraction Type (3 characters)²
- (c) Destination Identifier (7 characters)³
- (d) Serial Number (3 digits)⁴

The components should be separated by underscore characters (“_”).

An example of a **Post-16 Collection** file from a school to a local authority would be

6602050_P16_660XX26_001.XML

where **26** are the last two digits of the calendar year, and therefore appropriate to the return dated e.g. September 2026.

The total file name length **must** be 27 characters.

For files not yet authorised by the school the file extension should be changed from **XML** to **UNA**.

¹ For transfers from schools, the first 3 characters of the origin identifier will be the LEA code of the sending school and the final 4 characters will be the NAW school number of the sending school.

² For October Post-16 Collection data the survey type will be “P16”.

³ For transfers from schools to local authorities, the destination identifier will be the LEA code of the receiving local authority followed by “XX” and then “26” where “26” is the last two digits of the calendar year.

⁴ The first file in the series shall be “001”, the second “002” etc.

Wherever possible, software should indicate to the user which pupil's record is causing the error message. We suggest listing at least **<UPN>**, **<Forename>**, **<Surname>**, and **<DOB>** for this purpose. However, please note that the UPN should not be printed out.

Software is only required to validate learning activities within specific general programmes. Validation rules for these programmes will be included in **Validation CBDS v2627.1.n**.

The Validation CBDS contains filters to help during development. Users of the spreadsheet can filter on the collection.

9. School summary

Each time a submission is created by the software, or edited by the school, the software should automatically generate a school summary file.

The Welsh Government will be providing a set of XSLT files to process the xml data and produce a school summary report. The report, as set out in this section, is that produced by the XSLT.

This should be a formatted text file, using the attached layout of content, but the precise formatting is not specified. The main consideration is that the summary be easily readable both in the school and by the local authority, regardless of any difference between the software that generated it and that being used to read it.

Some references and notes (italicised) are included in the attached layout explaining the derivation of the numbers in this summary from the xml data submission (using xml tags, where appropriate), where this may not be self-evident. These notes should not appear on the summary itself. Square brackets also indicate explanatory notes which are not for inclusion in the report.

The summary file should be sent to the local authority as an automatic accompaniment to the data submission.

The purpose of the school summary is:

- to help the school staff preparing the return - and the head teacher authorising it - to assess its accuracy and completeness at a glance; and
- to help local authority staff to do the same, and to make immediate comparisons with any other information which they already hold (for example data from previous returns).

10.1 Important notes

In all summary tables:

- All ages are as at 31 August 2025;
- Only pupils registered at the school should be included in the summary report (i.e., guest pupils should be excluded);
- Only learning activities which fall within the relevant academic year should be included in the summary. Learning activities which have been completed in 2026/27 or started after 31 August 2026 should not be included.
